**GOLF COURSE AGREEMENT** - At the December 12, 2017 meeting, the Board approved the Chapel Hill Golf Course Consulting and Services Agreement.

**VILLAGE LIABILITY INSURANCE** - At the December 12, 2017 meeting, the Board approved a proposal from Arthur J. Gallagher Risk Management Services, Inc in the amount of \$98,745.50 for the Village's Property Casualty, General Liability and Worker's Compensation insurance.
